

CONFIRMATORY AFFIDAVIT

I, Arnold Michael Stainbank, better known as **Mike Stainbank**, do hereby make oath and state that I am an adult whose fuller personal and contact details are known to the State Capture Commission and all three Superior Courts in South Africa.

1. I confirm BlackHouse Kollektive Soweto references to me. I declare, as I have since 2018, that I am willing to assist this Commission. However, because mainstream media, under **South African National Editors Forum**, flatly refused us editorial coverage and to this day perpetuate lies about fascist low-life Jewish criminals, Solly and Abe Krok as originators of The Apartheid Museum, it is incumbent on me, to emphasise, as supplementary evidence, one critical issue that arises in the context of the memorandum BHK has submitted to the State Capture Commission.

2. **FREEDOM PARK, PRETORIA** under the Presidency of Thabo Mbeki cost taxpayers over R1Billion. The project started when trustees were appointed in December 1999. Records of the Cabinet Meeting of 31 May 2000 reflect: **Trustees of Freedom Park Trust: NELSON MANDELA – PATRON & MR JOE MODISE – CHAIRPERSON. TRUSTEES:** Prof GJ Gerwel; Ms Frene Ginwala; Mr Roger Jardine; Mr John Matshikiza; Mr Itumeleng Mosala; Mr Dikgang Moseneke; Mr Wally Serote; Mr Rob Adam; Ms Lindsay Bremmer; Ms Luli Callinicos; Rev Mvume Dandala; Mr Oscar Dhlomo; Prof Willie Esterhuyse; Mr Greville Fox; Ms Faith Gaza; Mr Ahmed Kathrada; Ms Barbara Masekela; Mr Govan Mbeki; Ms Joyce Sebidi; Ms Getrude Shope.



3. On 27 November 2018, **Advocate Isaac Vincent Maleka SC**, one among other evidence leaders at the SCC, told Chairman Raymond Zondo that he owns nothing in life: ***“except my professional integrity.”***
4. On 12 November 1997, Advocate Maleka SC, Chairman of the Gauteng Gambling Board, listened when Solomon Krok addressed him directly: *“I just want to add something, without discussing with my colleagues and co-shareholders and directors, I believe **FREEDOM PARK** is a must-see attraction and I believe that we will do everything in our power to make sure that we build that project even if we have to scale down the rest of the enterprise because we think that what South Africa needs is tourism. I think it behoves us to do that. So, only as a last resort would we cut down the **FREEDOM PARK.**”*
5. For twenty-three years Maleka SC, notwithstanding, ***the only thing he owns in his life***, never told South Africans nor millions of international tourists that the Gold Reef City Casino TEMPORARY License, was granted on the strict condition that FREEDOM PARK is built within three years.
6. No President, since Mandela, has ever told South Africa that FREEDOM PARK originates as a project conceived by Solly and Abe Krok in their bid for the casino licence. FREEDOM PARK PRETORIA is a plagiarised bastardisation of the content of my 1998 prospectus. The Apartheid Museum OWNED by Gold Reef City Casino is Jewish dilution and bastardisation of my Registered Trademark: The Apartheid Museum®

8. IN CLOSING CHAIRMAN ZONDO (DCJ)

I was born into the violence of colonial apartheid racism. I could never have imagined anything more depraved, more inhumane. Because the past twenty years have been far too painful for me to bear, I promise to ensure that your loved ones will never experience the unrelenting violence that you have visited on my children and grandchildren.
